

## Annexation requirements

1. Fire District No. 6
2. Owner name/parcel No. \_\_\_\_\_ / \_\_\_\_\_
3. Tax payer's name must be correct in the resolution, parcel number, and /or legal description.
4. Legal description Section, Township, and Range must be correct.
5. The regular description ie. NE1/2, SE1/4, etc. Must be complete and accurate.
6. Descriptions in Meets and Bounds for a Tax No. can be located on the Deed or Survey, and must be accurate.
7. A clear map showing at least one Section corner, Fire District No.6 boundary, and the exact location of the property to be annexed.
8. A boundary of the proposed annexation must be adjacent to a Fire District No.6 boundary.

All of the above requirements must be complete and accurate before the Annexation can be approved by the Fire Commissioners of Stevens County Fire District No.6.
