The Kettle Falls Area Chamber of Commerce would like to inform you of the EXCITING things that we are doing and the many changes being made to the organization. Additionally, we would like to draw your attention to all of the BENEFITS of being a member.

In conjunction with our TWO current festivals, *Town and Country Days* and *Festival of Neighbors*, we will be adding at least one more event this year. We are proud to announce that the *Crossroads Stage Blues Festival* will be held in Happy Dell Park this summer on June 17th & 18th. We anticipate that over 200 people will attend this two-day festival – many of whom will be camping at the park and local campgrounds and staying in local motels.

These festivals bring an influx of people to our community - with a corresponding increase in revenue for most local businesses. Many of these visitors call or stop by the Chamber Information Building for literature and personal recommendations from the volunteer staff. Their first recommendations are always to businesses who are Chamber members. Member businesses are also welcome to display brochures, flyers and business cards in this important venue.

Additionally, the Chamber has joined forces with the Kettle Falls Business Networking Group. This group has focused more on networking and supporting the members' business development goals – which has included hosting and promoting classes – and networking is now a regular part of our meetings.
